Dear Minister,

I would like to congratulate you on your appointment as Minister for the Environment and Climate Change. On behalf of the Catholic Bishops of Canada, I assure you of our prayers and our earnest hope to be able to collaborate with you and with all the Government of Canada.

This past November 4, I wrote to Prime Minister Trudeau, drawing his attention to several issues of common concern which the Catholic Bishops of Canada consider of immediate and pressing urgency (please find enclosed a copy of my letter). Among the concerns was our desire to encourage the Government to continue along the lines already indicated by the Prime Minister – namely, of cooperating with other states and collaborating with our country's provincial, territorial, and municipal governments in response to today's urgent climatic, environmental and related social challenges. In this regard, I pointed out the importance of the encyclical *Laudato Si'* by Pope Francis which was issued earlier this year. I am taking the liberty of enclosing complimentary copies for you in English and French.

In a fashion similar to the appeal I made to the Prime Minister, I also ask you to ensure that in your efforts to include wide representation in consultations or meetings by the federal government on the environment, invitations be extended as well to faith-based organizations and agencies, related interest groups as well as industry. All the different and complementary segments of Canadian society need to take responsible action on the challenges that the world, our "common home", faces regarding climate and the environment.

Moreover, faith-based representation in social and national discussions is especially important because each religion expresses itself through a framework of a general worldview and ethical principles which relate its beliefs to everyday action, and so motivate personal and social change. As an example, I am enclosing copies in English and French of a publication issued in early 2013 by our Conference's Commission for Justice and Peace, *Building a New Culture: Central Themes in Recent Church Teaching on the Environment.* Furthermore, faith-based organizations today are deeply involved in ecumenical and interreligious collaboration, and thus are able to provide compelling examples to all of society on the important, beneficial and

indispensable nature of honest dialogue and prophetic collaboration, most especially on questions which can be difficult, challenging and involving different but critical perspectives. The Canadian Council of Churches has already brought to the attention of the Prime Minister, with a copy to you, of the joint statement which it published – co-signed by representatives of Christian Churches, including me, as well as by leaders of other religions in Canada – which is entitled *On Promoting Climate Justice and Ending Poverty in Canada* (https://www.councilofchurches.ca/wp-content/uploads/2015/09/Faith-Communities-in-Canada-Speak-Out-EN.pdf).

As examples of the interest and commitment specific to Canadian Catholics regarding climatic and environmental challenges, I draw your attention to the following:

On a final point, I urged the Prime Minister, and now also urge you as Minister for the Environment and Climate Change, to work toward fair, binding and truly transformational climate agreements, both nationally and internationally. This recommendation is shared by all the Catholic Episcopal Conferences of the world, for the most part working through regional episcopal councils, which recently made public a 10-point appeal to the negotiators at the 21st Session of the Conference of the Parties (COP 21) in preparation for the upcoming Framework Convention on Climate Change. I am enclosing a copy of the text, to which our Episcopal Conference is also a signatory.
